

- EBOLA OUTBREAK -
MEASURES TAKEN BY THE VARIOUS PORT AUTHORITIES IN WEST AND CENTRAL AFRICA

GUINEA *infected*
Port of CONARKY:
no official measure taken to date for incoming or outgoing vessels

SIERRA LEONE *infected*
Port of FREETOWN:
1. ALL crew to remain onboard during call
2. Reduce physical contact with outsiders to minimum required
3. Gloves and masks mandatory for anyone attending ship

LIBERIA *infected*
Port of MONROVIA:
1. ALL crew to remain onboard during call
2. Reduce physical contact with outsiders to minimum required
3. Gloves and masks mandatory for anyone attending ship

IVORY COAST
Port of ABIDJAN:
Mandatory sanitary inspection at anchorage prior to berthing authorization
Port of SAN PEDRO:
1. Vessels to provide copies of last sanitary control + copy of medical record book for past 20 days
2. Mandatory sanitary inspection upon berthing
4. NO ONE else to be allowed onboard until clearance by sanitary inspectors
3. Vessels to declare immediately any suspicion of Ebola onboard and raise Yellow Flag -> 21 days-quarantine of rest of crew to follow

GHANA
Port of TEMA:
1. Mandatory sanitary inspection at anchorage prior to berthing authorization
2. Health Declaration Form to be filled
3. Gloves, masks and sanitizer to be provided by ship at gangway to anyone attending onboard

TOGO
Port of LOME:
Mandatory sanitary inspection upon berthing for vessels arriving from infected countries

BENIN
Port of COTONOU:
no official measure taken to date

NIGERIA *infected*
Port of LAGOS:
1. Mandatory sanitary inspection at anchorage for vessels arriving from infected countries
2. Reduce physical contact with outsiders to minimum required
3. Gloves and masks mandatory for anyone attending ship

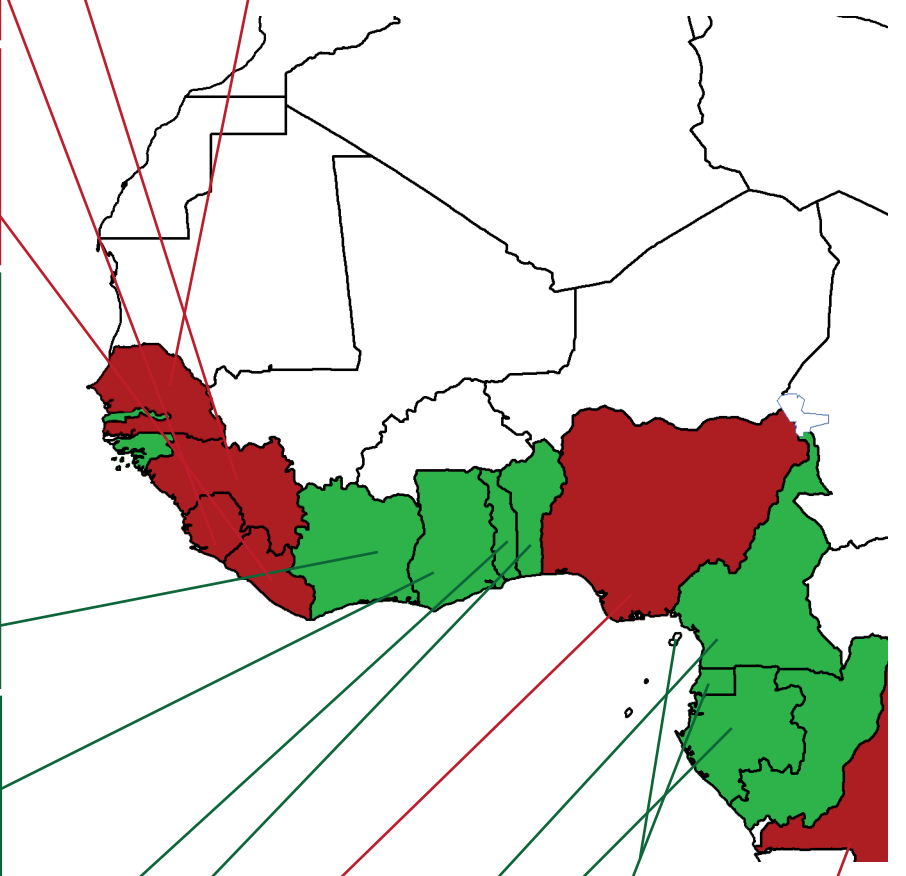
CAMEROON
Port of DOUALA:
As per information to date, vessels arriving from / having called in an infected country shall undergo a 21-days quarantine (from date of departure), to be followed by sanitary inspection.

SENEGAL *infected*
Port of DAKAR:
Mandatory sanitary inspection of all vessels arriving from other infected countries

GABON
Ports of OWNEDO, LIBREVILLE and PORT GENTIL:
1. Vessels to provide 24 hours before arrival copies of last sanitary control, medical record book for past 20 days, list of ports called over past 30 days precising those where crew change took place
2. Mandatory sanitary inspection at anchorage prior to berthing authorization
3. ALL crew to remain onboard during call + no crew change allowed
4. Gloves and masks mandatory for anyone attending ship

DEM.REP. of CONGO *infected*
Port of MATADI and BOMA:
no official measure taken to date for incoming or outgoing vessels

EQUATORIAL GUINEA
Ports of BATA and MALABO:
As per information to date, the local Maritime Authorities have ordered a complete BAN of any vessel having called in an infected country.
